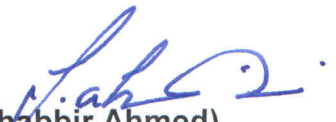
Islamabad, the 5th October, 2015

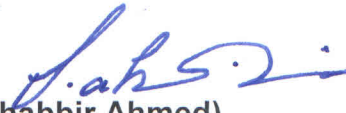
